MOTION TO DISMISS OF INDIVIDUAL-CAPACITY FEDERAL DEFENDANTS

Pursuant to Federal Rule of Civil Procedure 12, the individual-capacity federal defendants, James Brown, Bruce Chadbourne, Brian Geary, David Hamilton, George Lewis, Jim Martin, Richard McCaffrey, Julie Myers, Derek Moore, David Ostrobinski, Ronald Preble, David Reilly, Stephen Riccardi, George Sullivan, John Torres, Wilfred Valentin, Edgar Vasquez, Michelle Ventrano-Antuna, and Walter Wilkowski ("Defendants"), hereby move to dismiss all of the claims asserted against them in this action.

The Plaintiffs allege in their amended complaint that the Defendants violated Plaintiffs' Fourth, Fifth, and Tenth Amendment rights through the Defendants' alleged participation in an immigration enforcement operation conducted in New Haven, Connecticut, on June 6, 2007. Plaintiffs assert four claims pursuant to *Bivens v. Six Unknown Named Agents of the Federal Bureau of Narcotics*, 403 U.S. 388, 397 (1971), premised on this alleged conduct. All of Plaintiffs' claims against the Defendants should be dismissed under Federal Rule of Civil Procedure 12(b)(1), (2) and/or (6), because the Court lacks subject-matter jurisdiction over the claims and personal jurisdiction over several Defendants; Plaintiffs' fail to state cognizable

claims; and the Defendants' are entitled to qualified immunity. The grounds for this motion are set forth more fully in the supporting memorandum of law.
