## Bill,

In 2005, when we, i.e., the committee of which I was co-chair, was reviewing the AFM for its initial public online publication, we discovered that Chapter 12 was in the throes of revision. According to my AFM spreadsheet, Chapter 12 went to DOMO Associate Director Mike Aytes for concurrence on 07/09/2007 as AD05-01. See attached draft memo and draft AFM update. I see no evidence that Mike Aytes concurred on the Chapter 12 update, e.g., no memo was posted on uscis.gov under laws, policy memoranda. Obviously, there's nothing in the AFM.

Note that although Chapters 12.1-12.5 were apparently never updated, we added Chapter 12.6 around November 2005 as AD06-05, and then updated Ch 12.6 as AD11-34 on June 7, 2011.

<u>ERROR</u> on uscis.gov Immigration Policy and Procedural Memoranda page. The bottom of the page states, "Last updated: 04/20/2010"; however, the most recent memo is dated July 13, 2011/
